Who can participate?	Participation in this Offer is open to NSW Gyprock Trade Centre customers who are Australian residents aged 18 years or over and who hold a valid CSR Gyprock Trading Account, whether cash or credit (“Claimants”). Verification and Gift Card Delivery	Claimants may be required to provide or confirm their full name, email address, phone number, business name, CSR Gyprock Trading Account number and any other details reasonably required by the Promoter to verify eligibility and arrange Gift Card delivery. Claimants must retain their original purchase receipt, tax invoice or account record as proof of purchase. Failure to produce proof of purchase when requested may, in the absolute discretion of the Promoter, result in the Claimant being deemed ineligible and forfeiting any right to receive a Gift Card. Proof of purchase must clearly specify the Eligible Product/s purchased, the Participating Store, the purchase value and that the purchase was made during the Offer Period. General	The Promoter reserves the right, at any time and in its sole discretion, to verify the validity of any and all Qualifying Purchases. The Promoter may disqualify any Claimant who tampers with the claim process, breaches these Terms and Conditions, submits or relies on false, misleading or incomplete information, or engages in conduct that may jeopardise the fair and proper conduct of the Offer. Errors and omissions may be accepted at the Promoter's discretion. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved. A Gift Card will only be awarded following any validation and verification that the Promoter, or its nominated agents, requires in their sole absolute discretion. If this Offer is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention, fraud, supply issues or administrative error, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any Claimant; or (b) to modify, suspend, terminate or cancel the Offer, as appropriate. If there is a dispute as to the identity of a Claimant, the Promoter reserves the right, in its sole discretion, to determine the identity of the Claimant.
Collection and use of Personal Information	The Promoter collects personal information of Claimants, including without limitation their name, email address, phone number, business name, CSR Gyprock Trading Account number and any other information reasonably required to conduct the Offer, verify eligibility and arrange delivery of Gift Cards ("PI").

Unless otherwise indicated by the Promoter, the Promoter may disclose PI to entities outside of Australia as outlined in the Promoter's Privacy Policy. By participating in this Offer, Claimants consent to overseas transfer on these terms as permitted by the Australian Privacy Principles and agree that the Promoter is not liable in this regard. Participation

2. Participation must occur during the Offer Period and will be deemed valid only when the Qualifying Purchase has been successfully completed and validated by the Promoter. The Promoter is not liable for communications network problems, system issues, technical failures or administrative delays outside its control.
3. Participation that is incomplete, invalid, fraudulent or does not comply with these Terms will be deemed invalid. The Promoter accepts no responsibility for participation that is late, lost, delayed, incomplete, incorrectly submitted or otherwise not received due to any reason beyond the Promoter's reasonable control.
4. Where a Claimant participates on behalf of a business entity, the Claimant warrants that they have appropriate authority or permission to do so.

Liability

5. Nothing in these Terms limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("**Non-Excludable Guarantees**"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Offer.

Miscellaneous

6. The Promoter reserves the right to disqualify any Claimant who it believes to be deceptive or where their claim is not compliant with these Terms, or where it believes a Claimant has tampered with or manipulated the Offer process.
7. The Promoter reserves the right to request that Claimants produce identification, documentation or other information to confirm the Claimant's age, identity, address, CSR Gyprock Trade Account status (if applicable) or eligibility under this Offer, or to validate any information submitted. If requested documentation or information is not provided or fails to confirm the matter giving rise to the request, the claim will be deemed invalid.
8. If a Claimant breaches these Terms, they will be deemed ineligible to receive the Gift Card or the Gift Card may be withdrawn or forfeited at the Promoter's discretion. Verification is at the discretion of the Promoter, whose decision is final. Any failure by the Promoter to enforce any of its rights does not constitute a waiver of those rights.
9. The Promoter reserves the right to cancel, suspend or amend this Offer at any time without liability.
10. All Promoter decisions are final. No correspondence will be entered into.
11. The laws of New South Wales govern this Offer, and Claimants accept the non-exclusive jurisdiction of the courts and tribunals of New South Wales.
