

CLUB GYROCK 5,000 Bonus Points Incentive August 2026

TERMS AND CONDITIONS

Promoter	CSR Building Products Limited trading as CSR Gyprock (ABN 55 008 631 356) of Trinita 3, 39 Delhi Road, North Ryde NSW 113.
Offer Period	6:00am (AEST) on 1 August 2026 to 11:59pm (AEST) on 31 August 2026.
Who can claim?	Offer is open to Australian residents aged 18 years or over who are Club Gyprock members and have not made a purchase on their CSR Gyprock trading account since 1 May 2026 ("Claimants"). Employees or contractors aged 18 years and over may claim on behalf of an eligible business entity, provided the business entity name is disclosed at the time of purchase.
Who can't claim?	The directors, management and employees (and their immediate families, including spouses, ex-spouses, de-facto spouse, children or step-children (whether natural or by adoption), parents, step-parents, grandparents, step-grandparents, siblings, uncles, aunts, nieces, nephews and first cousins) of: (i) the Promoter; or (ii) the agencies or companies associated with this offer.
Purchase requirements	To be eligible to claim, Claimants must, during the Offer Period, spend a minimum of \$100 at a Gyprock Trade Centre using their CSR Gyprock trading account (cash or credit) ("Qualifying Purchase"). Claimants must provide their CSR Gyprock trading account details at the time of making their Qualifying Purchase. For clarity, the required spend amount does not have to be in a single transaction/order and can be made up of multiple transactions/orders over the Offer Period.
Club Gyprock Bonus Points	Every valid Claimant who makes a Qualifying Purchase during the Offer Period will receive 5,000 Club Gyprock Bonus Points, credited to their Club Gyprock trading account by 10 September 2026. Only one claim permitted per Club Gyprock trading account during the Offer Period. If multiple Claimants share the same Club Gyprock trading account, that Club Gyprock trading account will only receive the reward once (regardless of which Claimant made the Qualifying Purchase). - Participation must occur during the Offer Period and will be deemed valid only when the Qualifying Purchase is recorded against the Claimant's CSR Gyprock trading account. The Promoter is not liable for communications network problems, system issues or technical failures outside its control.
- Participation which is incomplete and does not meet the claim requirements or does not comply with these Terms, will be deemed invalid. The Promoter accepts no responsibility for participation that is late, lost or delayed.
- Where a Claimant is a corporate entity, the person participating on the corporate entity's behalf must warrant that they have appropriate authority or permission to participate on behalf of that entity.

Liability

- Nothing in these Terms limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("**Non-Excludable Guarantees**"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the offer.
- Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any tax liability incurred by a claimant; or (e) use of a reward.
